Leslie Burger

Leslie Burger is the President of the American Library Association. She will serve as ALA president beginning in July 2006 through June 2007. Leslie served as president of ALA's Association of Specialized and Cooperative Library Agencies (1996-1997), the New Jersey Library Association (2001-2002), and the Connecticut Library Association (1982-1983), and as an ALA Chapter Councilor. Additionally, she has served on many ALA committees and task forces since she joined the association in 1976. Leslie has directed the Princeton Public Library since 1999. From 1999-2004,

Leslie planned and funded the new 58,000 square foot Princeton Public Library, which opened to great community excitement in April 2004. In 1991, Leslie also founded her consulting firm, Library Development Solutions. In her consulting practice, Leslie has guided more than 100 urban, suburban, and rural public libraries, academic and special libraries, state libraries, and single and multi-type library cooperatives across the US in strategic planning, space needs assessments, evaluation and program implementation. Leslie attended library school at the University of Maryland in College Park and also has a master's degree in organizational behavior from the University of Hartford. She received the Princeton YWCA Tribute to Women Award in 2003, the New York Times Librarian Award for 2004, and was honored as the University of Maryland's CLIS Alumna of the Year in 2005.

Peter Morville

Peter Morville is president and founder of Semantic Studios, a leading information architecture, user experience, and findability consultancy. Recognized as the father of information architecture, he serves as a passionate advocate for the critical role that findability plays in defining the user experience. Peter's latest book, *Ambient Findability*, explores search, wayfinding, marketing, information interaction, literacy, librarianship, authority, and culture at the crossroads of ubiquitous computing and the Internet. Peter is also co-author (with Louis Rosenfeld) of the best-selling book, *Information Architecture for the World Wide Web*, named "Best Internet Book of 1998" by Amazon and "The Most Useful Book on Web Design on the Market" by usability guru Jakob Nielsen. As CEO of Argus Associates (1994-2001), Peter helped build one of the world's most respected information architecture firms, serving clients such as AT&T, Barron's, HP, IBM, L.L.Bean, Microsoft, Procter & Gamble and the Weather Channel. He has also worked with libraries, universities, nonprofits and foundations. Peter served on the Advisory Group charged with revising the ANSI/NISO Z39.19 standard for monolingual controlled vocabularies, and he currently serves on the Editorial Advisory Board of the *Encyclopedia of Library and Information Sciences*. Peter received an advanced degree in library and information science at the University of Michigan's School of Information, where he now serves on the faculty. Dr. Owen, an archivist and Louisville historian for the past 33 years, is a full professor at the University of Louisville. He has been a history instructor, archivist and community relations associate at U of L since 1968, as well as serving on the Louisville Board of Aldermen from 1990-1998, and was elected to the first Louisville/Jefferson County Metro Council in November 2002. Dr. Owen is well known as a local historian and is a frequent contributor to radio and television features; he also conducts tours of local sights and is a speaker on state and local history. He holds a Ph.D. in American History from the University of Kentucky; a master's in history from U of L; a bachelor of divinity from Methodist Theological School in Ohio; and a bachelor of arts degree from Kentucky Wesleyan. Dr. Owen has been awarded the Distinguished Service Award from the Louisville Historical League; the Outstanding University of Louisville Employee Award; an honorary membership in the Kentucky Chapter of the American Institute of Architects; and recently a Patron Service Award at the University of Louisville Libraries.

Ron Crouch is Director of the Kentucky State Data Center located at the University of Louisville. The Kentucky State Data Center is the official clearinghouse for Census data for the state of Kentucky. KSDC provides data on population, housing, education, employment, and other social indicators. Historical data, current data, and projections are provided to help understand trends and issues facing individual states and the country as a whole. Ron's background is in analyzing data and developing information in ways that enhance understanding and utilization. Ron's vocation is that of "knowledge dissemination". He averages around 150 presentations per year around Kentucky and across the United States. He is a graduate of the University of Louisville with a major in Sociology, and minors in Political Science and Economics. He holds Masters degrees in Sociology, MA, and in Social Work, MSSW, from the University of Louisville, and a Master in Business Administration, MBA, from Bellarmine University. Since October 2004, Watts is the Executive Director of the National Fair Housing Training Academy (US Department of Housing and Urban Development) in Washington, DC. Prior to that position, Watts served as the third Executive Director of the Kentucky Commission on Human Rights. During her tenure she introduced reengineering strategies to improve overall performance in case processing time; increased funding; expanded civil rights research; expanded education and outreach initiatives; and developed partnerships and collaborations with diverse groups and organizations. Watts was known as a champion for civil rights in Kentucky, throughout the US and internationally.

Prior to his university appointment, he was a secondary school teacher and teacher-librarian in Australian and New Zealand schools. His primary teaching and research interests focus on adolescent information seeking and use, information technology and learning, how school libraries and the role of the teacher-librarian may more effectively empower student learning, and knowledge management and building schools as effective information-knowledge sharing communities. He has published over 80 papers and book chapters on these areas, and has been an invited speaker at many international conferences. He is Co-Director of the Center for International Scholarship in School Libraries (<http://cissl.scils.rutgers.edu>) which aims to provide an arena to develop, exchange, and disseminate research enhancing the utilization of information for learning in school libraries worldwide.

Libraries for All: The Carnegie Experiment in Kentucky

Presenter: Jonathan Jeffery, Kentucky Library & Museum, Western Kentucky University

Andrew Carnegie believed the public library was the one place—particularly for the poorly educated immigrant – available for “universal education.” He backed his idealism with capital. From 1886 to 1923, Carnegie donated a total of \$56 million for construction of over 2500 libraries. Kentucky ranked 27th in the United States in the number of Carnegie grants received with only 15 communities taking advantage of the program. Neighboring Indiana and Ohio ranked first and fifth, respectively. Why did Kentucky lag behind? The reasons range from ignorance, to government parsimony, to population distribution, to public statute. For those Kentucky communities benefiting from Carnegie's largesse, did the library – as both an institution and an artifact – fit the concept of a “universal” place for public culture, education, and beauty? Using slides, Jeffery will explore these probing questions.

Microsoft Shared Computer Toolkit: Securing Computers for the Public

The Microsoft Shared Computer Toolkit is software that allows librarians to secure computers for the public. One component, Windows Disk Protection, erases all of the changes to the hard drive when the computer is rebooted. A second component, User Restrictions, allows restrictions similar to Group Policy on individual User Profiles for a standalone computer. The Gates Foundation recommends the Toolkit for the computers donated to libraries across Kentucky.

Cultivating Information Literacy in First-Generation College Students

Web Redesign for Distributed Content Management

The University of Kentucky Libraries recently completed an extensive revision of the library website. The existing flat file structure — in place since the first library website in 1995 — was replaced by a database-driven site. The primary goals of the redesign were: Faster updating through distributed content management, consistency of design and navigation within the site, standards compliance and accessibility. Technologies new to the site include PHP, MySQL, and Cascading Style Sheets. We also developed our own content management system and created new web policy and guidelines documentation. The entire redesign process took about two years and involved a wide range of library personnel throughout the system. The presenters will describe the process, including pitfalls and successes, assess the process and final result, and discuss lessons learned.
